ORDER

Sanction was accorded for the creation of 49 posts including one post of Computer Programmer on Consolidated Pay in the State Election Commission, Kerala. The following posts were also declared as addition to the cadre of Additional Secretary to Government, Joint Secretary to Government and Information Officer in the PRD respectively.

- (i) Secretary
- (ii) Administrative Officer
- (iii) Finance Officer
- (iv) Public Relations Officer.

The State Election Commission has informed Government that, the method of appointment has not been prescribed for appointment in respect of the remaining posts. The posts are now being filled up either by transfer or on deputation. The Accountant General (Kerala) has also insisted that specific terms and conditions as well as period of appointment may be fixed for the appointment made against the sanctioned posts in the State Election Commission on deputation from other departments including Government Secretariat. The State Election Commission in his letter read as 7th paper above has proposed that in addition to the posts which were already declared as Addition to the Cadre of posts, the following posts may also be declared as addition to the cadre of posts in respective Departments.
