ORDER

As per the provision contained in the Government Order read as 1st paper above, if sweeping area of an office, as per the guidelines prescribed, exceeds 900M² more than one Part Time Contingent Sweeper can be engaged. The Secretary, State Election Commission in the letter read as 3rd paper above has informed that the Assistant Executive Engineer, Public Works Department (Buildings), Thiruvananthapuram has certified that the sweeping area of the office of the State Election Commission is 964.43M². As such the State Election Commission has furnished proposal along with required details/certificates for the creation of one post of Part Time Contingent Sweeper in addition to the existing one post as per the provision contained in the Government Order read above.

Government have examined the proposal in detail and are pleased to create one post of Part Time Contingent Sweeper on a monthly remuneration of Rs. 2300 + DA.


