ORDER

Government are pleased to declare the following days as public holidays for all Public Offices and Educational Institutions and a paid holiday for all Government/Quasi Government and Commercial

Establishments in the area covered under those districts in connection with the General Election to Local Self Government Institutions 2015.

2nd November 2015 (Monday) — Thiruvananthapuram, Kollam, Idukki, Kozhikode, Wayanad, Kannur, Kasaragod.

5th November 2015 (Thursday) — Pathanamthitta, Alappuzha, Kottayam, Ernakulam, Thrissur, Palakkad, Malappuram.

(2) The Labour Commissioner will make necessary arrangements with all Private Enterprises, Private Industrial Centres and other Private Institutions under the Shops and Commercial Establishment Act and located on the aforesaid areas to declare the day of poll as a paid holiday for their employees. No deduction or abatement of the wages of any such persons shall be made on account of a holiday having been granted in accordance with law and if such person is employed on the basis that he would not accordingly receive wages for such a day, he shall nonetheless be paid for such a day, the wages he would have drawn had not a holiday been granted to him on that day.

(3) Employees including casual workers who are ordinarily resident of the above constituency where poll is taking place, and registered as an elector in that constituency but serving/employed in an industrial undertaking or an Establishment located outside the constituency where he/she is resident have to be given the benefit of paid holiday on the day of poll.
