State Election Commission – General Election to LSGIs in Kerala 2015 – Appointment of Expenditure Observers – Orders issued.

**ORDER**

As per Section 40 A of the Kerala Panchayat Raj Act, 1994 and Section 96A of the Kerala Municipality Act, 1994, the State Election Commission may nominate adequate number of higher officials of the Government as Observers, in consultation with the Government, to ensure a fair and equitable election of Panchayats and Municipalities and for discharging other functions as may be entrusted by the Commission. The State Election Commission has decided to nominate officers not below the rank of a Deputy Secretary as Expenditure Observer for the areas covered by two or more Block Panchayats and Municipalities in connection with the General Election 2015 to Local Self Government Institutions.

2. As per the papers read above, the Additional Chief Secretary, Finance Department and the Director of Kerala State Audit Department have furnished lists of officials, to be nominated as Expenditure Observers as desired by the Commission.

3. In the above circumstances, the following officials, stated in column No.2, are nominated to the Block Panchayats and Municipalities, stated in column 5, as Expenditure Observers for observing the election process and campaign organised by the candidates or political parties so as to ensure that the expenditure incurred for each candidate is within the limit as envisaged in the Kerala Panchayat Raj Act -1994 and Kerala Municipalities Act 1994.
