State Election Commission – General Election to LSGIs in Kerala 2015 –
Posting of General Observers – Orders issued.

ORDER

As per Section 40 A of the Kerala Panchayat Raj Act, 1994 and Section 96A of the Kerala Municipality Act, 1994, the State Election Commission may nominate adequate number of higher officials of the Government as Observers, in consultation with the Government, to ensure a fair and equitable election of Panchayats and Municipalities and for discharging other functions as may be entrusted by the Commission. The State Election Commission has decided to nominate officers in the cadre of IAS or IFS as General Observers for each district, in connection with the conduct of General Election to Local Self Government Institutions.

2. As per the papers read above, the Govt. have furnished the list of officials for nominating them as General Observers, as desired by the Commission.

3. In the above circumstances, the officers stated in column No.2 are nominated to the district stated in column 4 as General Observers in the election to the Panchayats and Municipalities, for ensuring a free, fair and equitable election.
