2) The above rates are payable to the staff for attending training classes, collecting polling materials etc. and also for attending duty on the Polling day/Counting day. These rates will come into force prospectively and is applicable to byelections and General Election 2010 and will have no retrospective effect.

3) The staff deployed at an polling stations/counting centres shall be provided with packed lunch and or light refreshment at the rate of Rs.100/- per head per day. In case of difficulty in providing packed lunch, a cash payment at the rate of Rs.100/- per head shall be made.

**ORDER**

As per the proceedings read above, the rate of sale price of electoral rolls and list of Polling stations is Rs.1.5 per page plus Sale Tax and AST. Considering the increase in the cost of paper and other expenditure, the State Election Commission is pleased to revise the existing rate per page to Rs.2.00 plus VAT as per Rules.

2. The electoral roll should be sold only in complete sets for each constituency and should not be split up and sold in parts. The cover page, the title page or pages and the total number of pages in the rolls (including supplements) should be taken into account for the purpose of calculating the total cost of a copy of the electoral roll of a constituency.

3. The sale proceeds should be credited to the Head of Account "0070-02-101-800-Other Receipts". The VAT will be credited to the appropriate Head of Account.

**ORDER**

In connection with the ensuing General Election to Local Self Government Institutions, the ballot boxes used for the election purposes have to be degreased, cleaned and prepared for poll and dispatched to distribution centres at the appropriate time to issue the same to the Polling Personnel. As per the proceedings read above, the rates of coolie charges for the purposes were as follows:

(2) The request to revise the above rates has been received by the State Election Commission from various District Collectors, considering the hike in the coolie charges and the materials. State Election Commission has examined the request and is pleased to revise the rates of coolie charges for this purpose as detailed below:

(3) The scale of materials to be used for cleaning the ballot boxes will be 10 litres of kerosene oil and 1 Kg. cotton waste for 100 Ballot Boxes. Purchase of the material will be arranged by the District Election Officers.

(4) The requirement of boxes may be calculated at the rate of 2 boxes (big size) per polling station plus a reasonable number of reserve boxes for every Block. In districts where Oriental type boxes are also available, the Alwyn type boxes preferred to the Oriental type. However, sufficient number of Oriental type should also be kept in reserve. While degreasing and cleaning the boxes it should be ensured that the corners and joints inside the boxes are cleaned properly. Boxes in sound condition alone need be selected for cleaning and distribution.

**ORDER**

The State Election Commission is pleased to revise the rates towards Coolie Charges of Polling Booth arrangement in connection with General Election to Local Self Government Institutions 2010, as shown below.

1. The Coolie Charges of booth arrangements at the rate of Rs.135 (Rupees One Hundred and Thirty Five only) for Government buildings and Rs.165/- (Rupees One hundred and Sixty Five only) in the case of Private buildings.

2. The hire charge of petromax at the rate of Rs.100/- (Rupees One Hundred only) per day is sanctioned to polling booths where electric supply is not available. In case of this claim the responsible Officer/Returning Officer should obtain certificate that the booth has no electric connection, from the concerned Assistant Executive Engineer of the Board.
