In exercise of the powers conferred by sub rule (1) of Rule 12 of Kerala Panchayat Raj (Conduct of Election) Rules, 1995 and the Kerala Municipality (Conduct of Election) Rules, 1995 and paragraph 7 of the Local Authorities Election Symbols (Reservations and Allotments) Order, 2017, the State Election Commission, Kerala, hereby, make the



following amendments to the Notification No.278/2020/SEC dated 6<sup>th</sup> November, 2020 and published in the Kerala Gazette Extraordinary No.2690, dated 6<sup>th</sup> November, 2020, namely:-

### AMENDMENT

### **EXPLANATORY NOTE**

(This does not form part of the notification, but is intended to indicate its general purport)

The State Election Commission, Kerala, as per Notification No.278/2020/SEC dated 6<sup>th</sup> November, 2020 and published the Kerala Gazette Extraordinary No.2690, dated 6<sup>th</sup> November, 2020 has published the list of National Parties, State Parties in Kerala and symbols reserved to them for contesting elections to Local Self Government Institutions in Kerala. But subsequently, the Election Commission of India as per Notification No.56/2020/PPS-II(NP) dated 15<sup>th</sup> May, 2023, has revised the list of National Parties and State Parties and symbols reserved for them. Therefore, the State Election Commission, in exercise of the powers conferred under sub rule (1) of rule 12 of the Conduct of Election Rules, has decided to alter the lists of National Parties and State parties in Kerala by way of amendment to the existing notification so as to enable the the Returning Officers to assign symbols to the contesting candidates from that list.

This notification is intended to achieve the above object.
