

Preface



Democracy is a system of Government by the whole population or all the eligible members of State, typically through elected representatives. The word 'democracy' has been derived from two Greek words 'demos' and 'kratos' which means 'People, Rule or Strength'. In Greece the reference to democracy is to the middle of the 5th/4th century BC, in Athens. However, democracy and democratic institutions have their roots in ancient India right from Vedic age (Circa 3000-1000 BC). 'Sabha' and 'Samiti' are two such democratic institutions referred at several places in Rigveda. Grama Panchayat was the cradle of domestic democracy, 'Panchayat' literally means 'Council of Five'. That too has its origin in ancient India. A village council of the residents of the village consisting of the elders known as Panchayat or Gramasangha performed administrative and judicial functions in the villages. Sometimes such Panchayat or Gramasanghas were manned by elected representatives also. There are references to Gramasanghas in Manusmriti, Kautilya's Arthashastra and Mahabharata. Valmiki's Ramayana speaks of the Ganapada, a federation of village republics. The membership in Ganapada was restricted to those persons who were committed to the general welfare of the people. It is pertinent and interesting to note that membership was specifically denied to 'durjana', people who are not interested in the welfare of others and people who do not possess good qualities in life. Thus it can be seen that the village panchayats manned by 'sajjana' had an unbroken continuity in India throughout her long history and that is the source and basis of democracy in this country. Democracy thus became one of the basic features of Indian Constitution.

Preparation and maintenance of Electoral roll is the foremost democratic practice in connection with the election of the representatives of the people to the Parliament, Legislature and Local Self Government Institutions. Those constitutional mandates under Article 324 & 243 (K) are entrusted with Election Commission of India in the case of Parliament and Legislature and vice versa in State Election Commission in case of Panchayat Raj and Nagarapalika Institutions, which are commonly known as Local Self Government Institutions in our State.

Kerala State Election Commission undertook Summary Revision of the Electoral Roll during June - July 2024. I hope the report with analysis on the revision will be very useful for all the stakeholders.

2. BACKGROUND

The new Part IX has been incorporated into the Constitution of India, 1950 after the 73rd and 74th amendments in 1992 viz., Part IX provides the Constitution of Panchayats and its Constitutional functional basis and Part IX A also provides the Constitution of Municipalities and its Constitutional functional basis under Article 243.

The 73rd and 74th Constitutional Amendments gave the Constitutional status to Panchayat Raj Institutions and Nagarapalika institutions respectively, in both letter and spirit in order to bring about greater decentralization of power and increase the involvement of the community in planning and implementing schemes, and thus increase accountability. The political empowerment of Panchayat Raj Institutions and Nagarapalika institutions has been firmly established by way of decentralized governance of the elected representatives of the three tier Panchayat Raj and Nagarapalika Institutions. As part of the empowerment of local governance in Kerala, The Kerala Panchayat Raj Act, 1994 and The Kerala Municipality Act, 1994 came into existence by repealing the Kerala Panchayat Act, 1960 and The Kerala Municipality Act, 1960. As per the new Kerala Panchayat Raj Act, 1994, a three tier Panchayat Raj Institutions ie; Grama Panchayat in bottom level, Block Panchayat in Middle level and District Panchayat in Top level in each districts, were established for rural local governance and as per Kerala Municipality Act, 1994, Municipal Corporations and Municipal Councils were established for urban local governance of the state. These are the Local Self Government Institutions in our State. The present strength of LSGIs in the State are listed below.

The total constituencies/wards comprised in the above institutions are **21900**. The Electoral Registration officers prepare electoral rolls for their respective constituencies under the direction of the State Election Commission. There is no need to register as voters in the constituency of Block and District Panchayats separately because such constituencies are

the collection of Grama Pachayat Constituencies in the three tier system. Basically the voters for the three level reside in Grama Pachayat area.

The State Election Commission gives direction to Electoral Registration Officers from time to time to revise and prepare electoral roll based on the sections 16 to 28 of the Kerala Panchayat Raj Act, Sections 73 to 84 (A) of the Kerala Municipality Act and the Electors Registration Rules, 1994.

The number of LSGIs and its constituencies/wards are given in category wise in districts

3. STATE ELECTION COMMISSION

The State Election Commission is constituted under Articles 243 K and 243 ZA of the Constitution of India for the superintendence, direction and control of the preparation of the electoral rolls for, and the conduct of all elections to the Panchayats and the Municipalities in the State. The State Election Commission, Kerala came into existence in 3rd December 1993. The State Election Commissioner is appointed by the Governor of Kerala under clause (1) of Article 243 K of the Constitution of India. The Government, as per Notification SRO No.978/2013 issued in GO(Ms) No.378/2013/LSGD, dated 05.12.2013 have conferred on the State Election Commissioner the status, salary and allowances of a Judge of the High Court. The tenure of the State Election Commissioner is for a period of five years from the date he assumed charge or till he attains the age of 65 years, whichever is earlier.

Kerala State Election Commission is a single Member Commission. The Electoral Roll for the election to Panchayats and Municipalities has been prepared and maintained under the supervision, control and direction of the Commission since 1995.

4. ELECTORAL REGISTRATION MACHINERY

The following officers come into the array of this machinery.

I. State Election Commission

Article 243 K and 243 ZA empower the SEC, the superintendence, direction and control of the preparation of electoral rolls for panchayats and municipalities respectively. As per Section 12(4) of the Kerala Panchayat Raj Act, the State Election Commission shall, in consultation with the Government designate or nominate such of the officers of the Government or of the local authority as officers for the purpose of preparation and revision of electoral rolls under this act.

Rule 3 of the Kerala Panchayat Raj (Registration of Electors) Rules, 1994 / the Kerala Municipality (Registration of Electors) Rules, 1994 provides power to State Election Commission to prescribe the form, language and its manner of the electoral roll of each constituency.

II. District Election Officer

As per Section 13(1) of the Kerala Panchayat Raj Act and Section

of the Kerala Municipality Act, the State Election Commission may designate one or more persons as Assistant Electoral Registration officers to assist any Electoral Registration Officer in the performance of his functions.

Provided that every such person shall be an officer of the Government or of a panchayat. Every Assistant Electoral Registration officer shall, subject to the control of the Electoral Registration Officer, be competent to perform all or any of the functions of the Electoral Registration Officer.

The following officers are the Assistant Electoral Registration Officers at different level of Local Self Government Institutions:

Grama Panchayat	- Assistant Secretary/Junior Superintendent/ Head Clerk/ Accountant
Municipal Council	- P.A. to Secretary, Revenue Officer, Municipal Engineer and Superintendent
Municipal Corporation	- Deputy Secretary/Revenue Officer, PA to Secretary, Council Secretary, Accounts Officer and Engineers

VI. Appellate Authority

a) District Election Officer

As per Section 25 of the Kerala Panchayat Raj Act and Section 81 of the Municipality Act, an appeal shall be within such time and in such manner, as may be prescribed to the District Election Officer from any order of the Electoral Registration Officer under Section 23 or 24 and Section 79 or 80 of the Act respectively.

Every appeal under Section 25 or 81 of the Act shall be accompanied by the prescribed fee which shall, in no case, be refunded.

b) District Joint Director (LSGD)


As per Rule 22 of the Kerala Panchayat Raj (Registration of Electors) Rules / the Kerala Municipality (Registration of Electors) Rules, an appeal shall be from any decision of the Registration Officer under rule 18, 19 or Rule 20 of the rules to such officer of Government as the State Election Commission may designate in this behalf.

Provided that an appeal shall not lie where the person desiring to appeal has not availed himself of his right to be heard by, or

to make representations to the registration officer on the matter which is the subject of appeal.

Every appeal shall be (a) in the form of a memorandum signed by the appellant and accompanied by a copy of the order appended against and a fee of Rs. 2/- to be paid. The above remittance may be by means of non-judicial stamps or court fee stamp or other means prescribed by the State Election Commission.

The above appeal can be submitted through in person or by registered post and that should reach appellate officer within 15 days from the date of order of the registration officer.



5. ELECTORAL REGISTRATION PROCESS

State Election Commission directs Electoral Registration Officers to prepare and publish voters list through online as per the given schedule of programme of detailed instructions. Almost all the works related to filing applications, its processing and preparing the voters list are done in online mode through ERMS (Electoral Roll Management System) software powered by NIC. (Visit SEC portal, www.sec.kerala.gov.in for availing voter related services.)

Schedule

1. Date of publication of draft Voters List
2. Last date of filing claims and objections (Minimum 15 days from Sl. No. 1)
3. Date of completion of procedures on claims and objections and final updation (Minimum 10 days from Sl. No. 2)
4. Date of publication of final voters list (Minimum 2 days from Sl. No. 3)

Supervision, Co-ordination, Control and Directions

State Election Commission - Statewide
 District Election Officers & District Collectors - Districtwise

Eligibility Criteria

1. Citizen of India
2. 18 years of age completed on January 1st in the last preceding year
3. Ordinarily resident in a constituency of a local body
4. with sound mind
5. No bar from court etc...

Draft Publication

In the ERMS software, mother roll and supplementary rolls are integrated electronically to a single roll for the draft publication. The roll is assigned polling station wise. Electoral Registration Officer publishes the roll in the Form 3 notice in stipulated places for making claims and objections, transposition and correction by the citizen.

(The forms mentioned in this segment are the notified forms in the Kerala Panchayat Raj (Registration of Electors) Rules, 1994 / the Kerala Municipality (Registration of Electors) Rules, 1994).

Name Inclusion

The citizens having following eligibility can file application in Form 4 through online for including their name in the voters list.

The pravasi applicants can also file applications through online following special procedure in Form 4 A which is provided exclusively before any election.

Objection

The Voter of a constituency can make any objection in Form 5 with another voter of the same constituency as supporter against the names already included and for fresh inclusion of names.

Correction and Transposition

The existing voter can file application for correcting his entreis in the voters list in Form 6 and transfer name from one part to another part within same local body in Form 7.

Process of Applications

The ERO disposes all applications in Form 4, 4 A, 5, 6 and 7 through quasi judicial process followed by the principles of natural justice viz., preparing and serving notice, hearing of parties, inquiry and enquiry in the field, etc. The ERO has to take utmost care throughout the process and he should convince himself of the decision taken in his official capacity.

Final Publication of Voters List

After completing the process and preparation, ERO publishes the list finally in Form 16 at the stipulated places.

Appeals

The applicants who are unsatisfied with the decision of ERO can prefer appeal within 15 days of communication of decision to respective appellate authorities.

7. SUMMARY REVISION PROCESS

State Election Commission is empowered under Section 22(2) (b) of the Kerala Panchayat Raj Act and Section 78 (2)(b) of Kerala Municipality Act 1994 to revise summarily the existing voters list of all Local Self Government Institutions specially except before any of the General or Bye-Elections.

The above Sections 22 and 78 provides the electoral roll for each constituency in a Local Self Government Institution shall be prepared in the prescribed manner by reference to the qualifying date and shall come into force immediately upon its final publication in accordance with the rules made under the Acts.

The Section 22(2)(b) and the section 78(2)(b) also provides that the above said electoral roll "shall be revised in any year in the prescribed manner by reference to the qualifying date if such revision has been directed by the State Election Commission".

The Electoral Rolls for local body were last revised during the September - October 2023 as part of Summary Revision. Hence the Commission again decided to revise summarily voters list of all Panchayats and Municipalities in the State vide order No.B2/99/2024/SEC dated 28.05.2024 with the following time schedule during the June - July 2024, fixing qualifying date as 01.01.2024. The revision carried out following Rules 7 to 22 of the Kerala Panchayat Raj (Registration of Electors) Rules, 1994 / the Kerala Municipality (Registration of Electors) Rules, 1994.

This venture done in manner followed by the last year Summary Revision, 2023, which was first of its kind undertaken by the State Election Commission.

The preparatory works for this Special Summary Revision was unique and exemplary. SEC trained District Level Trainers to impart comprehensive training to Electoral Registration Officers, Assistant Electoral Registration Officers, Election Clerks of LSGI and Technical Assistants of the Panchayats and Municipalities to familiarise with the

guidelines issued by the Commission about the activities to be done prior to the revision and regarding online processing of applications. The district level trainers were selected by the District Election Officers concerned with the approval of the Commission.

The State level monitoring was very keen at district levels by the Nodal Officers and Assistants of the SEC under the guidance of Hon'ble Commissioner and Secretary of the SEC. The contribution of the IT Cell of SEC and NIC is to be noted specially in the successful roll revision process. District level co-ordination and monitoring from the office of DEO, Election Deputy Collector, Election Assistants and District Joint Director, LSGD and his office were very effective and commendable during the revision process.

In addition to the above, a large number of field staff and staff of transferred institutions of LSGI were actively involved and contributed so much effort to become this revision process a grand success.

The prime intention of this Special Summary Revision was the purification of the existing voters list. The Electoral Registration Officers have done Suo-moto removal of deceased voters and those were shifted residence from the constituencies. New voters were also enrolled. When the revision was completed **4,52,951** voters were deleted from the draft roll published on 06.06.2024 and **2,71,085** new voters including Pravasi Votes of **2178** enrolled in the final list Published on 01-07-2024.








12. THE WAY FORWARD

The right of vote for a citizen in India, is based on the constitutional principle of universal adult suffrage, which is very important salient feature of the Constitution of India. For enabling this right, every citizen has to be included in the voters list. The population of Kerala as per 2011 census comes to **3,34,06,061**. Total SEC voters in Kerala as on 01.07.2024 is **2,66,75,157**. Total populaton as per Census 2011 minus voters enrolled in SEC voters list comes to **67,30,904**. This difference cannot be considered as persons who are the under age of 18 years. The exact figure of persons, under 18 years can be ascertained only after the completion of the ensuing census. In this context, it cannot be assumed that whether all eligible citizens have been enrolled. 100% voter registration is the prime focuss of SEC. A proposal to link voters list with aadhar has been given to the government for suitable

legislation.

The Constitution of India empower the existence of 'Grama Sabha' and the Article 243A provides that 'A Grama Sabha may exercise such powers and perform such functions at the village level as the legislature of a state may, by law, provide'.

The preamble of the Kerala Panchayat Raj Act, 1994 says that "for securing a greater measure of participation of the people in planned development and in local government affairs, by constituting village, block and district panchayats;

And such Panchayats with such power and authority to enable them to sanction as institutions of self-government;

And entrusting such panchayats the preparation of plans and implementation of schemes for economic development and social justice including the implementation of schemes in relation to the matters listed in the 11th Schedule to the Constitution."

Section 3(2) of the Kerala Panchayat Raj Act also says that "All persons whose names are included in the electoral rolls relating to a village comprised within the area of a village panchayat shall be deemed to be constituted as Grama Sabha of such village." For achieving the above goal, Grama Sabha is devised by law.

Hence, Grama Sabha is an apex body of the panchayat. The eligibility condition of being member of a Grama Sabha, he or she has to be enrolled in the electoral roll of that constituency. Now **15,962** Grama Sabhas are functioning in Kerala with **2,07,47,207** members.

In Kerala Municipality Act 1994, it is provided for formation of Ward Sabha and Ward Committees.

In this context, the enrolment of all eligible voters in the voters list is essential to strengthen the democratic process in the LSGIs.
