#### EXPLANATORY NOTE

(This does not form part of the notification, but is intended to indicate its general purport)

As per Notification No.24/2025/SEC dated 25<sup>th</sup> August, 2025 issued by the State Election Commission by virtue of its powers under section 41 of Kerala Panchayat Raj Act, 1994,

- The Special Tahasildar (LA), NH No. III, Vyttia was designated as Returning Officer of G.42 Udayamperoor Grama Panchayat in Ernakulam District. Now, it is reported that he was posted as Land Acquisition Officer for NH-544. Accordingly, the District Election Officer, Ernakulam has submitted a proposal for replacing the officer by amending the said notification.

Accordingly, the District Election Officer, Wayanad has submitted a proposal for replacing the officer by amending the said notification.
- iv) The Assistant Executive Engineer, Minor Irrigation Subdivision, Kalpetta was designated as Returning Officer of G.17 Muppainad Grama Panchayat in Wayanad District. Now it is reported that, he will be otherwise engaged in Mudakkai rehabilitation works. Accordingly, the District Election Officer, Wayanad has submitted a proposal for replacing the officer by amending the said notification.
- v) The Deputy Director of Education, Kalpetta was designated as Returning Officer of G.19 Muttil Grama Panchayat in Wayanad District. Now it is reported that, the Deputy Director of Education will be otherwise engaged in various youth festivals, monitoring and management of funds, inspections. Accordingly, the District Election Officer, Wayanad has submitted a proposal for replacing the officer by amending the said notification.
