## NOTIFICATION

Whereas in exercise of the powers conferred by sub rule (1) of Rule 12 of Kerala Panchayat Raj (Conduct of Election) Rules, 1995 and the Kerala Municipality (Conduct of Election) Rules, 1995 the State Election Commission, Kerala as per Notification No.278/2020/SEC dated 6<sup>th</sup> November, 2020, which was published in the Kerala Gazette Extraordinary, No.2690 dated 6<sup>th</sup> November, 2020, had published list of symbols;



Whereas sub rule (1) of Rule 12 of Kerala Panchayat Raj (Conduct of Election) Rules, 1995 and the Kerala Municipality (Conduct of Election) Rules, 1995 also empowers the State election Commission to elaborate or alter the symbols;

Whereas paragraph 5 of the Local Authorities Election Symbols (Reservation and Allotment) Order, 2017 enables a political party, other than a recognized National party or State party, who is desirous of getting specific symbol, to make an application to the Commission for the purpose;

And whereas paragraph 6 of the Local Authorities Election Symbols (Reservation and Allotment) Order, 2017 enables a political party or a person authorized by political party to file objection to the Commission regarding the allotment of symbol to a political party;

Now, therefore, in exercise of the powers conferred by sub rule (1) of Rule 12 of Kerala Panchayat Raj (Conduct of Election) Rules,1995 and the Kerala Municipality (Conduct of Election) Rules, 1995 the draft amendment to the said notification is hereby published for information of political parties so as to make application for allotment of symbol or to file objection to the allotment of symbol, as the case may be and notice is hereby given that the draft amendment will be taken into consideration by the Commission after the expiry of thirty days from the date of this notification;
