#### **EXPLANATORY NOTE**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification No. 25/2025/SEC dated 23<sup>rd</sup> August, 2025 issued by the State Election Commission by virtue of its powers under section 97 of Kerala Municipality Act, 1994,

- i) The Revenue Divisional Officer, Adoor was designated as Returning Officer of M08 Adoor Municipality, Pathanamthitta District. Now, it is reported that the Revenue Divisional Officer is engaged in Sabarimala mandalakala sanitation and allied duties. Accordingly, the District Election Officer, Pathanamthitta has submitted a proposal for replacing the officer by amending the said notification.
- ii) The Revenue Divisional Officer (Sub Collector, Thiruvalla) was designated as Returning Officer of M10 Thiruvalla Municipality, Pathanamthitta District. Now, it is reported that the RDO is engaged in Sabarimala mandalakala sanitation and allied duties. Accordingly, the District Election Officer, Pathanamthitta has submitted a proposal for replacing the officer by amending the said notification.
